FEEDING DIRECTIONS

This product is formulated for grazing beef cattle on pasture or range. Recommended consumption is 4 ounces (0.25 lbs) per head per day. Free choice salt should also be provided. Feed continuously near the cattle's source of water.

CAUTION: Consumption of this product by sheep and goats may result in copper toxicity. Follow label directions. The addition to feed of higher levels of this premix containing selenium is not permitted.

NOTE: To be fed as the sole source of selenium. Beef Cattle should not receive more than 3 mg selenium. When mixed, rations should not contain more than 0.3 ppm selenium
