FEEDING DIRECTIONS

CAUTION: Consumption of this product by sheep and goats may result in copper toxicity. Follow label directions. The addition to feed of higher levels of this premix containing selenium is not permitted.

NOTE: To be fed as the sole source of selenium. Beef Cattle should not receive more than 3 mg selenium. When mixed, rations should not contain more than 0.3 ppm selenium
